Subject:	Proposal for a Directive of the European Parliament and of the Council on the conditions of entry and residence of third-country nationals for the purposes of research, studies, pupil exchange, remunerated and unremunerated training, voluntary service and au pairing [Recast] [First reading]
	- Approval of negotiation mandate

1. On 26 March 2013, the Commission submitted a proposal for a Directive on the conditions for entry and residence for the purposes of research, studies, pupil exchange, remunerated and unremunerated training, voluntary service and au pairing. The proposal amends and recasts Directive 2004/114/EC of 13 December 2004 on the conditions of admission of third-country nationals for the purposes of studies, pupil exchange, unremunerated training or voluntary service and Directive 2005/71/EC on the conditions of admission of third-country nationals for the purposes of scientific research. Its objective is to improve the legal framework applicable to the categories of third-country nationals covered by the two above mentioned directives as well as to extend the scope of the directive to two new categories of third-country nationals: remunerated trainees and au pairs.

- 2. The European Parliament voted its first reading position on 25 February 2014 which serves as a mandate for the negotiations with the Council.
- 3. The Working Party on Integration, Migration and Expulsion started discussing the proposal in April 2013. Issues that raised most concerns among delegations related to the scope of the Directive, the intra-EU mobility of the categories of third-country nationals concerned and the rights granted to third-country national under this Directive. On 12 November 2014, the Permanent Representatives Committee discussed a central outstanding issue concerning the scope of the Directive. The Presidency held a series of bilateral meetings thereafter to solve this and other outstanding issues. The JHA Counsellors discussed the proposal on 17 November and 2 December in order to finalise the compromise text suggested by the Presidency. The result of these examinations with delegations' comments in the footnotes is set out in document 16343/14. As a result of these discussions, the Presidency has prepared a compromise text which is reflected in the Annex to this Note. Changes to the previous text in document 16343/14 are indicated with **●**]...] **●**.
- 4. The Permanent Representatives Committee is asked to:
  - agree on the text in Annex I that could serve as a mandate for the Presidency for engaging in negotiations with the representatives of the European Parliament, in order to reach a second reading agreement with the European Parliament on this proposal as soon as possible;
  - to inscribe the statement of Belgium and Portugal, as it appears in Annex II, in the minutes of its meeting.

#### THE EUROPEAN PARLIAMENT AND THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty  $\boxtimes$  on the Functioning of the European Union  $\bigotimes$  establishing the European Community, and in particular points (3) (a)  $\boxtimes$  and (b)  $\bigotimes$  (4)(b)of the first subparagraph of Article (3)  $\boxtimes$  79(2)  $\bigotimes$  thereof,

Having regard to the proposal from the European Commission,

After transmission of the draft legislative act to the national Parliaments,

Having regard to the Opinion of the European Economic and Social Committee,

Having regard to the Opinion of the Committee of the Regions,

Acting in accordance with the ordinary legislative procedure,

Whereas:

(1) A number of amendements are to be made to Council Directive 2004/114/EC of 13 December 2004 on the conditions of admission of third-country nationals for the purposes of studies, pupil exchange, unremunerated training or voluntary service<sup>1</sup> and Council Directive 2005/71/EC of 12 October 2005 on a specific procedure for admitting third-country nationals for the purposes of scientific research<sup>2</sup>. In the interests of clarity, those Directives should be recast.

- (2) This Directive should respond to the need identified in the implementation reports of the two Directives<sup>3</sup> to remedy the identified weaknesses, and to offer a coherent legal framework for different groups coming to the Union from third countries. It should therefore simplify and streamline the existing provisions for the different groups in a single instrument. Despite differences between the groups covered by this Directive, they also share a number of characteristics which makes it possible to address them through a common legal framework at Union level.
- (3) This Directive should contribute to the Stockholm Programme's aim to approximate national legislation on the conditions for entry and residence of third-country nationals. Immigration from outside the Union is one source of highly skilled people, and in particular students and researchers are increasingly sought after. They play an important role to form the Union's key asset human capital in ensuring smart, sustainable and inclusive growth, and therefore contribute to the achievement of the objectives of the Europe 2020 Strategy.

(5) For the gradual establishment of an area of freedom, security and justice, the Treaty provides for measures to be adopted in the fields of asylum, immigration and the protection of the rights of third-country nationals.

The Treaty provides that the Council is to adopt measures on immigration policy relating to conditions of entry and residence, and standards on procedures for the issue by Member States of long-term visas and residence permits.

At its special meeting at Tampere on 15 and 16 October 1999, the European Council acknowledged the need for approximation of national legislation on the conditions for admission and residence of third-country nationals and asked the Council to rapidly adopt decisions on the basis of proposals by the Commission.

(6) This Directive should also aim at fostering people-to-people contacts and mobility, as important elements of the Union's external policy, notably vis-à-vis the countries of the European Neighbourhood Policy or the Union's strategic partners. It should allow for a better contribution to the Global Approach to Migration and Mobility and its Mobility Partnerships which offer a concrete framework for dialogue and cooperation between the Member States and third countries, including in facilitating and organising legal migration.

One of the objectives of Community action in the field of education is to promote Europe as a whole as a world centre of excellence for studies and vocational training. Promoting the mobility of third-country nationals to the Community for the purpose of studies is a key factor in that strategy. The approximation of the Member States' national legislation on conditions of entry and residence is part of this.



## CHAPTER V

### PROCEDURE AND TRANSPARENCY

#### Article 14

#### **Applications for admission**

1. Member States shall determine whether applications for residence permits are to be made by the researcher or by the research organisation concerned.

2. The application shall be considered and examined when the third-country national concerned is residing outside the territory of the Member States to which he/she wishes to be admitted.

3. Member States may accept, in accordance with their national legislation, an application submitted when the third-country national concerned is already in their territory.

4. The Member State concerned shall grant the third-country national who has submitted an application and who meets the conditions of Articles 6 and 7 every facility to obtain the requisite visas.

#### Procedural safeguards

1. The competent authorities of the Member States shall adopt a decision on the complete application as soon as possible and, where appropriate, provide for accelerated procedures.

2. If the information supplied in support of the application is inadequate, the consideration of the application may be suspended and the competent authorities shall inform the applicant of any further information they need.

3. Any decision rejecting an application for a residence permit shall be notified to the third-country national concerned in accordance with the notification procedures under the relevant national legislation. The notification shall specify the possible redress procedures available and the time limit for taking action.

4. Where an application is rejected, or a residence permit, issued in accordance with this Directive, is withdrawn, the person concerned shall have the right to mount a legal challenge before the authorities of the Member State concerned.

## CHAPTER VI

## FINAL PROVISIONS

### Article 16

### Reports

Periodically, and for the first time no later than three years after the entry into force of this Directive, the Commission shall report to the European Parliament and the Council on the application of this Directive in the Member States and shall propose any amendments that are necessary.

#### **Transposition**

1. Member States shall bring into force the laws, regulations and administrative provisions necessary to comply with this Directive by 12 October 2007.

When Member States adopt these measures, they shall contain a reference to this Directive or shall be accompanied by such a reference on the occasion of their official publication. The methods of making such reference shall be laid down by Member States.

2. Member States shall communicate to the Commission the text of the main provisions of national law which they adopt in the field covered by this Directive.

#### Article 18

#### **Transitional provision**

By way of derogation from the provisions set out in Chapter III, Member States shall not be obliged to issue permits in accordance with this Directive in the form of a residence permit for a period of up to two years, after the date referred to in Article 17(1).

#### Common Travel Area

Nothing in this Directive shall affect the right of Ireland to maintain the Common Travel Area arrangements referred to in the Protocol, annexed by the Treaty of Amsterdam to the Treaty on European Union and the Treaty establishing the European Community, on the application of certain aspects of Article 14 of the Treaty establishing the European Community to the United Kingdom and Ireland.

#### Article 20

This Directive shall enter into force on the twentieth day following its publication in the *Official Journal of the European Union*.

### Transposition

Statement of Belgium and Portugal regarding the Proposal for a Directive of the European Parliament and of the Council on the conditions of entry and residence of third-country nationals for the purposes of research, studies, pupil exchange, remunerated and unremunerated training, voluntary service and au pairing [recast]

Regarding Article 21 on equal treatment, Belgium and Portugal wish to express their concerns on the possibility for Member States to apply exceptions regarding the rights in the field of social security as provided for in point (b) of article 12 (2) of Directive 2011/98/EU (Single Permit Directive) towards researchers, as this goes a step back compared to the existing legislation.

Belgium and Portugal shall pay particular attention to this Article during the negotiations with the European Parliament and the Commission.

In view of reaching an agreement, Belgium and Portugal can support the compromise proposal as presented by the Presidency in document 16343/14 of 3 December 2014 and agree that trilogue negotiations should start as soon as possible.

Belgium and Portugal request to add this statement to the minutes of COREPER.
